21-30 MPH OVER SPEED LIMIT	\$60.00 FINE + \$100.00 COSTS= \$160.00
31+ MPH OVER SPEED LIMIT	\$100.00 FINE + \$100.00 COSTS= \$200.00
SCHOOL ZONE (NO ACCIDENT)	\$100.00 FINE + \$100.00 COSTS= \$200.00

DRIVING WITHOUT VALID LICENSE:

MOVING (ACCIDENT)	\$75.00 FINE + \$100.00 COSTS= \$175.00
MOVING (NO ACCIDENT)	\$25.00 FINE + \$100.00 COSTS= \$125.00
NON-MOVING	\$20.00 FINE + \$ 60.00 COSTS= \$ 80.00

ADDITIONAL OFFENSE PER CITATION (-B, -C, etc.):

****DISTRACTED DRIVING (RC 4511.991)** - If the traffic ticket is marked that distracted driving was a contributing factor to the commission of the underlying traffic offense, then the defendant must pay **an additional fine of \$100.00** unless they show proof of completing a distracted driver safety course.

CRIMINAL OFFENSES

All minor misdemeanor criminal offenses may be processed in accordance with Criminal Rule 4.1. Therefore, in lieu of appearing in Court, the defendant may sign a plea of guilty and a waiver of trial and pay the fine and costs as follows:

MARIJUANA/PARAPHERNALIA POSSESSION: \$150.00 FINE + \$90.00 COSTS = \$240.00
DISORDERLY CONDUCT AND DC-INTOX: \$ 50.00 FINE + \$90.00 COSTS = \$140.00
OTHER MINOR MISDEMEANOR CRIMINAL: \$ 25.00 FINE + \$90.00 COSTS = \$115.00

COSTS-ADDT'L. OFFENSE (-B, -C, etc.): ABOVE FINE + \$20.00 COSTS

LATE FEE: \$15.00
